**Description of Issue: Approval of Budget Adjustments**

**Background and rationale for this program/item:**

The Administration is recommending adjustments to the FY12 Budget and annual transfers for Nutrition Service equipment and lease purchase of the annexation sites. These budget changes reflect revenue and expenditure adjustments. The annual ASBR requires Nutrition Services capital outlay to be coded to fund 40. End of year transfers are required to meet ASBR reporting and maintain accountability for the expenditures to Nutrition Services. The District received DESE authorization for the Debt Service Fund to reimburse the Capital Projects fund for annual lease payments of the annexation building lease. Special approval was given because the voters approved the annexation which resulted in the debt that would have otherwise been paid by Debt Service Fund.
