The Board of Education met in regular session Tuesday, April 12, 2022 at 6:00 p.m. in the Board Room at the Board of Education Office, 201 North Forest Avenue, Independence, Missouri.

The meeting was called to order by the President, Mrs. Denise Fears, and minutes of the meeting were recorded by the secretary, Ms. Annette Miller. Mrs. Fears welcomed those in attendance.

Eric Knipp made the motion to approve the minutes from the March 9, 2022 Board of Education meetings. The motion was seconded by Matt Mallinson and unanimously approved by the Board of Education.

Matt Mallinson made the motion that the Board of Education certifies the April 5, 2022 School Board member election results received from the Jackson County Board of Election Commissioners and the Kansas City Board of Election Commissioners with Jill Esry and Anthony J. Mondaine being elected as members of the Independence School District from April 2022 until April 2028.

The motion was seconded by Greg Finke and unanimously approved by the Board of Education.

Each of the Board members expressed their appreciation to Dr. Matt Mallinson for his service on the Board of Education since 2009. They appreciated his candor, insight, and valued his support on District issues brought before the Board of Education. Mrs. Fears presented Dr. Mallinson with a framed Board member picture listing his service from 2009-2022 and a Starfish Plaque commemorating his service and "the difference he made" to the Board of Education and the Independence School District.

Following the many comments by the Board of Education, Dr. Mallinson addressed the Board. He thanked each of the Board members for their friendship and support during the years he has served on the Board of Education. He asked the recently elected Board members to look at both sides of an issue and to consider what is best for all students. He asked the media to focus on positive occurrences in the District and not always on negative issues that they receive through various sources. At the end of Dr. Mallinson's comments, he thanked his wife, Kathy Mallinson, for supporting him through his tenure as a School Board member and he said in appreciation that he was taking her to a long awaited overdue dinner this evening.

The motion was made by Blake Roberson, second by Greg Finke, to adjourn the 2020-2022 Board of Education Sine Die. The motion was unanimously approved by the Board of Education.

Dr. Herl then reconvened the meeting and said the two recently elected members would be sworn in by the Board Secretary, Ms. Annette Miller.

Ms. Miller then administered the Oath of Office to Mrs. Jill Esry and Mr. Anthony J. Mondaine.

Following the swearing in ceremony, Dr. Herl asked for nominations for the office of President of the Board of Education for the 2022-2024 term.

Greg Finke made the motion to nominate Eric Knipp as President of the Board of Education for the 2022-2024 term. The motion was seconded by Blake Roberson. There were no other nominations and the motion was unanimously approved by the Board of Education.

Mr. Knipp called for nominations for the office of Vice President of the Board of Education for the 2022-2024 term.

Jill Esry made the motion to nominate Mr. Blake Roberson as Vice President of the Board of Education for the 2022-2024 term. The motion was seconded Carrie Dixon. There were no other nominations and the motion was unanimously approved by the Board of Education.

Mr. Knipp then called for nominations for the office of Treasurer of the Board of Education for the 2022-2024 term.

Greg Finke made the motion to nominate Mrs. Carrie Dixon as Treasurer of the Board of Education for the 2022-2024 term. The motion was seconded Denise Fears. There were no other nominations and the motion was unanimously approved by the Board of Education.

Mr. Knipp then called for nominations for the office of Secretary of the Board of Education for the 2022-2024 term.

Denise Fears made the motion to nominate Ms. Annette Miller as Secretary of the Board of Education for the 2022-2024 term. The motion was seconded Jill Esry. There were no other nominations and the motion was unanimously approved by the Board of Education.

Greg Finke made the motion that the Board of Education approves the Agenda as presented. The motion was seconded by Jill Esry and unanimously approved by the Board of Education.

Mr. Knipp stated that Mr. Jason Vollmecke had requested to address the Board of Education. Mr. Knipp read Policy 0412 regarding employees or patrons addressing the Board during the Board of Education meeting.

Dr. Jason Vollmecke, 2914 South Vermont Avenue, independence, MO 64052, requested to address the Board of Education regarding teacher retention and student safety. He shared statistics comparing teacher retention from the state that he said was on the DESE website. He talked about the Superintendent giving the Board of Education information and that he hoped the Board would review the information and check it out. He wants the Board to have all the information before making decisions for the District and not just basing their decisions on what the Superintendent provides. He said he wants students and staff to feel safe when they are at school.

The motion was seconded by Jill Esry and was unanimously approved by the Board of Education.

Dr. Herl shared several items under the Superintendent's Report. He said that school districts are transitioning from MSIP 5 to MSIP 6 and this is challenging based on using data from this year and not having clear expectations on this year's scoring. Dr. Herl reported that 881 of the 1,003 eligible certificated staff participated in the retention incentive which is equivalent to 87.8%. Dr. Herl said the legislative session continues in Jefferson City and following are several items of interest: 1) A number of legislation bills have been stalled due to the redistricting issue – either a 6-2 or 7-1 congressional map which is based on Democrat vs. Republican representation. 2) The state budget was passed by the House and is headed to the Senate appropriations committee. Districts not receiving more money that in 2007 considering the continuing inflation, currently no increase in school transportation but hopes that the Senate will make adjustments, and Prop C is a pass through as it is based on collections of state sales tax. Dr. Herl shared that SB 648 deals with virtual education: it does not allow local districts to determine best educational interest; it does say that districts ae not responsible for test scores when they come from a virtual school; and the bill will probably come out of committee and advance to the Senate floor. Dr. Herl said the District's COVID cases are down to 3 cases at this time.

Several items of business were shared for the Board of Education's consideration.

Dr. Grant, Nicole Sequeira, and Sherry Potter shared information on the District's mental health services for students. They shared information on the District's multi-tiered support system which includes academics, behavior, social, and emotional levels. The building level support system includes school counselors and Family School Liaisons, the District level includes school psychologists and agency partnerships, and the staff support system includes trauma sensitive and employee assistance programs.

Dr. Herl said that as part of the District's Comprehensive School Improvement Program, the Administration is recommending approving the bid from Leavell and Associates for hiring three (3) licensed qualified mental health professionals to provide therapeutic services for students at a cost of \$179,000.

Jill Esry made the motion that the Board of Education approves the bid from Leavell and Associates in the amount of \$179,000 to provide therapeutic services for Independence School District students. The motion was seconded by Greg Finke and was unanimously approved by the Board of Education.

Dr. Herl explained that due to additional inclement weather days, another adjustment to the 2020-2021 School District calendar is needed. The Administration is recommending using April 15, 2022 as a regular student attendance day and May 31, 2022 as a teacher work day.

Blake Roberson made the motion, second by Denise Fears, that the Board of Education approves adjusting the 2021-2022 School Calendar to include April 15, 2022 to a regular student attendance day in order to meet the required days/hours of attendance. The motion was unanimously approved by the Board of Education. (Page 12278)

Dr. Herl recommended appointing Ms. Debi Allen as the District's representative on the 2022 Jackson County Board of Equalization. He said that it is a thankless job and Debi Allen has agreed again to serve for the District.

The motion was made by Jill Esry, second by Carrie Dixon, that the Board of Education approves the appointment of Ms. Debi Allen as the Independence School District's representative to the 2022 Jackson County Board of Equalization. The motion was unanimously approved by the Board of Education.

Dr. Stout said that the District's Technology Plan updates the Chromebooks fleet periodically and the Administration is recommending purchasing 3,420 ACER C722 Chromebooks for \$1,048,264.20 and White Glove Service for \$46,500.00 from CDW-G for a total of \$1,094,764.20 under the Education Plus (Missouri) Schools) (018-A) Contract. This cost will be covered through ESSER III funds.

Jill Esry made the motion that the Board of Education approves the purchase of 3,420 ACER C722 Chromebooks and White Glove Service from CDW-G for \$1,094,764.20 under the Education Plus (Missouri) Schools) (018-A) Contract. The motion was unanimously approved by the Board of Education.

Dr. Stout said the Administration is recommending purchasing 350 Dell CTO 3420 laptops for \$348,250.00 and 315 Belkin Docking Stations for \$56,385.00 for middle school teachers and substitutes from CDW-G for a total of \$404,635.00. The laptops and docking stations will be paid through ESSER III funds.

Denise Fears made the motion that the Board of Education approves the purchase of 350 Dell CTO 3420 Laptops and 315 Belkin Docking Stations for ISD middle school teachers and substitutes from CDW-G for \$404,635.00

under the Education Plus (Missouri Schools) (018-A) Contract. The motion was seconded by Blake Roberson and unanimously approved by the Board of Education.

Dr. Stout said the Administration is recommending purchasing SMART Interactive Displays and installation from KCAV under the TIPS #200105 Contract for \$860,713.16. This will update classroom projection technology in the middle schools and will be funded with ESSER III funds.

Greg Finke made the motion that the Board of Education approves the quotes to purchase SMART Interactive Displays and installation from KCAV under the TIPS #200105 Contract for \$860,713.16. The motion was seconded by Jill Esry and unanimously approved by the Board of Education.

Dr. Stout explained that as part of the Technology Department's update plan, the Administration is recommending purchasing 456 Solo Spark II Document Cameras for \$119,827.68 from CDW-G under the Education Plus (Missouri Schools) (018-A) Contract. This cost will be paid through ESSER II and III funds.

Carrie Dixon made the motion that the Board of Education approves the purchase of 456 Solo Spark II Document Cameras from CDW-G for \$119,827.68 under the Education Plus (Missouri Schools) (018-A) Contract.. The motion was seconded by Blake Roberson and unanimously approved by the Board of Education.

Dr. Herl said new furniture is needed at Van Horn High School based on the remodeling/expansion of their cafeteria area. The Administration is recommending accepting the quote from SSI Furnishings for a total cost of \$109,376.71 for replacement of cafeteria furniture at Van Horn High School.

Jill Esry made the motion that the Board of Education accepts the quotes from SSI Furnishings for a total of \$109,376.71 for the replacement of furniture for the Cafeteria expansion/remodel at Van Horn High School. The motion was seconded by Carrie Dixon and unanimously approved by the Board of Education.

Dr. Herl said the District let bids to replace the roof above the family and consumer science classrooms and cafeteria prep area at Truman High School. The Administration is recommending acceptance of the bid from Cornell Roofing and Sheet Metal at a cost of \$589,000.00.

Jill Esry made the motion, second by Carrie Dixon, that the Board of Education approves the bid of \$589,000.00 from Cornell Roofing and Sheet Metal for roof replacement at Truman High School. The motion was unanimously approved by the Board of Education.

Dr. Herl said the Administration is recommending approval of bids for HVAC replacement at: (1) Thomas Hart Benton Elementary School, Glendale Elementary School, Christian Ott Elementary School, Proctor Elementary School, Spring Branch Elementary School, Sunshine Early Education Center and Sycamore Hills Elementary School from Energy Tech Solutions for a project cost of \$1,636,642; (2) James Bridger Middle School, Independence Academy, John W. Luff Elementary School and Clifford. H. Nowlin Middle School from Lippert for a project cost of \$961,444.30; and (3) George Caleb Bingham Middle School from Stanger Industries for a project cost of \$588,117. The total cost of the bids for this scope of work is \$3,186,203,30.

Blake Roberson made the motion that the Board of Education approves the bids for HVAC Replacement for Thomas Hart Benton Elementary School, Glendale Elementary School, Christian Ott Elementary School, Proctor Elementary School, Spring Branch Elementary School, Sunshine Early Education Center and Sycamore Hills Elementary School from Energy Tech Solutions for a project cost of \$1,636,642; James Bridger Middle School, Independence Academy, John W. Luff Elementary School and Clifford. H. Nowlin Middle School from Lippert for a project cost of \$961,444.30; and George Caleb Bingham Middle School from Stanger Industries for a project cost of \$588,117 as presented for the total cost of \$3,186,203.30. The motion was seconded by Greg Finke and it was unanimously approved by the Board of Education.

The Administration recommends accepting the proposal for installation of Automated Logic Controls at Thomas Hart Benton Elementary School, George Caleb Bingham Middle School, Jim Bridger Middle School, Glendale Elementary School, Independence Academy, John W. Luff Elementary School, Nowlin Middle School, Christian Ott Elementary School, Proctor Elementary School, Spring Branch Elementary School, Sycamore Hills Elementary School, and Sunshine Early Education Center from Control Service Company for a total cost of \$511,601. Dr. Herl explained that the current software and hardware are a Sole Source with Control Service Company due to the compatibility with the District's current system.

Denise Fears made the motion, second by Blake Roberson, that the Board of Education approves the proposal from Control Service Company for the installation of Automated Logic Controls at Thomas Hart Benton Elementary School, George Caleb Bingham Middle School, Jim Bridger Middle School, Glendale Elementary School,

Independence Academy Alternative School, John W. Luff Elementary School, Nowlin Middle School, Christian Ott Elementary School, Proctor Elementary School, Spring Branch Elementary School, Sycamore Hills Elementary School, and Sunshine Early Education Center for a total cost of \$511,601. The motion was unanimously approved by the Board of Education.

As part of the District's Facilities CSIP, the District will remodel the secure entry at Christian Ott Elementary School. Dr. Herl said the Administration recommends accepting the Guaranteed Maximum Price of \$2,052,840 from Nabholz Construction for this project which guarantees the District will not pay more than this amount for the project.

Jill Esry made the motion that the Board of Education accepts the Guaranteed Maximum Price of \$2,052,840 from Nabholz Construction for the remodel of the secure entry at Christian Ott Elementary School. The motion was seconded by Greg Finke and unanimously approved by the Board of Education.

Dr. Herl stated that the School District owns land near the northeast corner of Jackson Drive and Necessary Road consisting of two parcels of land containing 5.39 acres and 19.3 acres respectively, as further described in Exhibit A. The property is no longer required for use by the School District and the District wishes to declare the land surplus real property authorized for sale. He said that a developer is interested in acquiring the property for a housing development. The Administration recommends declaring this land as surplus property authorized for sale.

Greg Finke made the motion, second by Denise Fears, that the Board of Education declares the real property described in Exhibit A, in which ownership is vested in the District, is no longer required for the use of the District and is surplus property authorized for sale. The motion was unanimously approved by the Board of Education. (Page 12281)

There being no further information to come before the Board of Education, Greg Finke made the motion, second by Jill Esry, to adjourn the meeting and go into executive session for legal, personnel, and real estate issues at 7:10 p.m. The motion was approved as follows:
